(2) The Objectives of the BCOJ

- 1. To standardize analytical methods for the evaluation of materials and products adopted in beer brewing and other related industries.
- 2. To facilitate scientific and technological research through mutual communication among beer brewing industry specialists.
- 3. To work in collaboration with other foreign and domestic organizations with shared objectives.

The meetings of the Board Committee, Analysis Committee, Program Committee, and the Annual Meeting of the BCOJ were held to execute the mission of the BCOJ.

2. Science and Technology Exchange with American Society of Brewing Chemists (ASBC)

(1) Participation in the Brewing Summit 2018

The members of the BCOJ board participated in the Brewing Summit 2018, San Diego, CA, USA, from Aug. 12th to 15th, 2018, to promote technology exchanges with other participants and ASBC board members. During the conference, 20 c/s of Japanese beer was donated and served to delegates. BCOJ members were invited to the reception party held by the ASBC president, and networks among delegates were established.

(2) Participation in the International Networking Session

On the day before Brewing Summit 2018 (Aug. 11th), we held the International Networking Session, a joint holding of ASBC and BCOJ. Young researchers from ASBC and BCOJ gathered as a main objective of upgrading technology skills through mutual technical exchanges and held a short presentation on each subject's research topics and discussed places.

3. BCOJ Annual Meeting

During November 8–9, the 2018 BCOJ Annual Meeting was held at Seiryo-Kaikan, Tokyo. Approximately 290 scientists, brewers and engineers from five major Japanese breweries and related companies or ministries participated in the conference. Participants exchanged views on many beer-related issues including the development of attractive products, improvements in taste, and securing food safety.

Dr. Dana Sedin (the president of ASBC), Mr. Scott Britton (the next president of ASBC), and Dr. Xiang Yin (ASBC Asia Liaison Officer), were invited to the conference. The presentation, "Wood Aged/Sour Beer Flavor and Analysis," given by the ASBC president, was well-received by the audience. At the BCOJ Achievement Awards ceremony, a gift of shields and flowers was presented to Mr. Atsushi Murakami of Kirin Co., Ltd. As the invited lecture, Mr. Takahiro Inagawa, CEO, Interstellar Technologies Inc. talked about Present state and development of rocket development by private company in Japan.

2018 Annual Report of BCOJ Analysis Committee

The term for the annual activities of BCOJ Analysis Committee in 2018 was from January to December. The committee had eight meetings. The following individuals were the members of the committee.

1. The BCOJ Collaborative Work

BCOJ worked on the following collaborative study: "Determination of ethanol content in pitching yeast by Alcolyzer". It was concluded that the Alcolyzer method is capable of determining alcohol concentration in yeast slurries and yeast-containing semi-products. The above method by Alcoyzer has been approved by the National Tax Agency Japan since June, 2018. BCOJ worked on"Analytical method for hop aroma compounds by SPME-GC/MS" as well. Linalool, geraniol and β -myrcene have been chosen as target compounds. We are performing a preliminary evaluation to decide whether we should move on to hold a full collaborative test in 2019. Furthermore we are preparing potential BCOJ collaborative work "Alcohol measurement in RTD by Alcolyzer".

2. Revision of Sensory Evaluation Methods of BCOJ

We started to revise BCOJ Sensory Analysis Methods at the end of 2014. The contents of the Methods are originally derived from ASBC MOA and/or Analytica-EBC. Finally we completed the revision of *Sensory Evaluation Methods of BCOJ* and it was published in September. We will finish the payment of the copyright fees to ASBC and EBC until end of the year.

3. BCOJ Technical Seminar

BCOJ Technical Seminar was held on September 21. There were ca 40 participants from the member companies of BCOJ (BAJ).

The Program Committee in 2018 held five regular meetings for planning and implementation of the 28th Annual Meeting of the BCOJ (BCOJ 2018) and three extraordinary meetings for other specific topics. The Program Committee and Prof. Touhara of the University of Tokyo began the cooperative research on beer flavor in June 2008, and it was continued successfully until the end of May 2018.

The Program Committee contributed a review of BCOJ annual meetings to the Journal of the Brewing Society of Japan in September, entitled "Footsteps of the BCOJ Annual Meeting in a quarter-century".

BCOJ 2018 was held on November 8th and 9th. There were a total of 23 oral and poster presentations. Mr. Takahiro Inagawa (CEO, Interstellar Technologies Inc.) presented an invited lecture entitled "Present state and development of rocket development by private company in Japan."
