2. Science and Technology Exchange with the European Brewery Convention (EBC) and American Society of Brewing Chemists (ASBC)

2021 ASBC Meeting was held online from June 7 to 9. But just as last year, the members of the BCOJ board could not participate in the meeting on-site due to COVID-19.

3. BCOJ Annual Meeting


November 11 and 12, the 2021 BCOJ annual meeting was held online in real time. It was the first trial for BCOJ meeting, just like every other year, many participants (total 327 persons) from five major Japanese breweries and related companies or ministries joined in the conference. Participants exchanged views on many beer-related issues including the development of attractive products, improvements in taste, and securing food safety.

This year was the 30th anniversary of the BCOJ annual conference. The BCOJ board chair, analysis committee chair, and program committee chair reported on the topics of the BCOJ's activities and future vision. We also received video messages from the ASBC president (Mr. David Maradyn) and EBC president (Mr. Benet Fité Luís).

At the BCOJ Contribution Award Ceremony, the gift of shields and flowers was presented to Dr. Koji Suzuki (ASAHI QUALITY & INNOVATIONS, LTD.), and the commemorative lecture was given by him. In addition, Dr. Yuki Hanyu, CEO of IntegriCulture Inc., gave an invited lecture on "Cell Culture for Food Production".

1. The BCOJ Collaborative Work

Regarding the hop aroma component analysis in beer using the SPME-GC / MS method started in 2018, the optimum analysis conditions have been determined, so a collaboration test was conducted in 12 laboratories including 5 BCOJ member companies. As a result of statistical analysis of the acquired data, the HorRat value of all of the three components to be analyzed, that is, myrcene, linalool, and geraniol, was within 2.0, which was a good result, and the collaboration test was established.

We will prepare a report by the end of the year and make a presentation at the poster session of Brewing Summit 2022. (The managing company is Sapporo Breweries Ltd.)

2. Applying Alcolyzer for Alcohol Analysis to RTD

Aiming to register a method for measuring alcohol content other than those prescribed by the National Tax Agency (NTA), the application of the alcolyzer method to spirits and liqueur have been studied since 2019. This year, 10 laboratories from 5 BCOJ member companies participated in the collaborative test, and it was confirmed that there was no problem in the deviation of the measured value from the distillation method and the indoor / inter-chamber reproducibility. The application registration with the NTA was completed, and it was posted on the NTA website on October 8 as measurement method No. 12 "Measurement of alcohol content by BCOJ beer analysis method RTD-1 and RTD-2 alcolyzer method". Spirits are limited to those with an alcohol content of 20.0% by volume or less, and liqueurs are limited to those with an alcohol content of 10.0% by volume or less and an extract content of 13.0 degrees or less. Spirits and liqueur can be diluted with water within a range of 4 times under 15 °C conditions.

As a future issue, if there is a request from each company, we will consider whether dilution higher than 4 times or filter paper filtration or centrifugation operation of smoky or turbid samples, those are not permitted by this method, will be a problem.

3. The revision of the BCOJ beer analysis method

The CD-ROM version of the beer analysis method is the latest in 2013, and it has not been updated since then. In consideration of convenience and social situations, the members of each company and the BCOJ officers agreed that it is desirable to make regular revisions using the electronic version instead of the book or CD version. Therefore, as one of the main activities of next year, it is essential to determine the revised items of the analytical method and prepare the revised manuscript, and at the same time, we will consider how to proceed with the electronic version.

4. BCOJ Technical Seminar

BCOJ Technical Seminar was held online from 15:00 to 17:00 on June 4, 2021, with 43 participants.

We discussed the contents of the seminar with the instructor in advance. In addition to the basic contents, there were also practical contents related to the joint experiment, so it was a very meaningful.

2. Objectives of Program Committee
