The COVID-19 has affected the activities of BCOJ in 2022. Among the pandemic, the International Technical Committee was held 5 times, the Analysis Committee 7 times, and the Program Committee 10 times in order to achieve the objectives of BCOJ activities. Also, in August, we were able to attend the Brewing Summit 2022. This was the first time in three years since 2019 that we could participate in an overseas academic conference.

<The Objectives of the BCOJ>

- 1. To standardize analytical methods for the evaluation of materials and products adopted in beer brewing and other related industries.
- 2. To facilitate scientific and technological research through mutual communication among beer brewing industry specialists.

3. To work in collaboration with other foreign and domestic organizations having the same objectives.

1. Science and Technology Exchange with the European Brewery Convention (EBC) and American Society of Brewing Chemists (ASBC)

(1) Participation in EBC Congress

The dispatch of committee members to the 38th EBC Congress was canceled due to the deterioration of the pandemic situation in Europe in April and May before the conference was held. At the 38th EBC Congress, "THE DECLARATION BETWEEN EBC AND BCOJ" was scheduled to be renewed, but due to the cancellation of the participation in the Congress, the update of the declaration has been postponed to 2023 and will be renewed at the EBC Symposium.

(2) Participation in Brewing Summit 2022

After being absent from the 2020 World Brewing Congress and the 2021 ASBC Annual Meeting, which were held online because of the pandemic, we were able to attend Brewing summit 2022. It was the first time in three years to participate on site. In the summit, we discussed with ASBC Board members about post-pandemic management of academic conference.



(3) BCOJ Annual Meeting

The 31st BCOJ Annual Meeting was held on November 10-11, 2022. In view of the impact of COVID-19, BCOJ held the first hybrid event at the Seiryo Kaikan real venue and online distribution. Through presentations at the annual convention, which was attended by a total of 299 people from member of beer companies, related government agencies, companies, etc., we actively exchanged technical reports and opinions, leading to the improvement of technical knowledge related to the development of attractive products, the realization of deliciousness, and quality assurance.



From overseas, we welcomed ASBC President Ms. Kimberly Bacigalupo, her husband Brewer of Sierra Nevada Brewing Co. Mr. Justin Schoenthal and ASBC Asia Liaison Officer Dr. Xing Yin. Ms. Bacigalupo gave her keynote address "Kombucha and Beer – Friends or Foes?" We have received a letter from the EBC Chairman (Mr. Benet Fité Louis).

In addition, Dr. Hirotaka Kaneda, a professor at Kyushu Sangyo University received the BCOJ

Contribution Award this year.

Furthermore, Professor Hiroki Ota from The University of Tokyo gave an invited lecture.

Discussion about BAJ sponsored "alcohol-related joint research"

The Brewers Association of Japan has decided to discontinue its collaborative research on drinking (alcohol intake) and health.

In the future, we will discuss the research contents when issues in the beer industry [improvement of quality of life, relationship between eating habits and drinking (alcohol intake), etc.] are raised and a clear story can be drawn about the purpose, efforts, results, and their effects toward solving them.

1. The BCOJ Collaborative Work

Regarding the hop aroma component analysis in beer using the SPME-GC / MS method started in 2018, Mr. Kamiya made a presentation at the poster session of Brewing Summit 2022. (Lead manager is Sapporo Breweries Ltd.)

2. Applying Alcolyzer for Alcohol Analysis to RTD

Aiming to register a method for measuring alcohol content other than those prescribed by the National Tax Agency, the application of the Alcolyzer method to spirits and liqueur have been studied since 2019. The application registration with the NTA was completed, and it was posted on the NTA website as the measurement method No. 12 "Measurement of alcohol content by BCOJ

beer analysis method RTD-1 and RTD-2 Alcolyzer method" in October 2021. Then the results were presented at the poster session of Brewing Summit 2022 by Mr. Muro.

Filter paper filtration or centrifugation operation of smoky or turbid samples is not permitted by this method. The research for this issue has been begun.

3. The revision of the BCOJ beer analysis method

The CD-ROM version of the beer analysis method is the latest in 2013, and it has not been updated since then. We decided adding 8 BCOJ original analytical methods and revising 75 methods in accordance with the revision of Analytica-EBC and MOA of ASBC. By November, the checking of 8 additional BCOJ original analytical methods, other revisions, and 13 additional methods were completed.

4. BCOJ Technical Seminar

BCOJ Technical Seminar was held online from 15:30 to 17:00 on October 14, 2022, with more than seventy participants.

Title: Developing new businesses to realize personalized food services using AI related to food preferences

Instructor: Ms. Eriko Sekiya, Consultant

We discussed the contents of the seminar with the instructor in advance. In addition to the basic contents, there were also practical contents related to the joint experiment, so it was very meaningful.

5. International Activities

(1) EBC Analysis Group conference

The EBC Analysis Committee meeting was held on May 28th and 29th, 2022 in Madrid. Vice chairperson participated and reported on BCOJ activities.

The EBC Analysis Committee meeting was held in a completely online on September 22nd, 2022. Chairperson participated.

(2) ASBC Technical Committee meeting

The meeting was held on August 17th, 2022 in Providence. Chairperson, vice chairperson and two general managers of BAJ participated, and Chairperson Inui reported on BCOJ activities.

(3) EBC Collaborative Work

Four BCOJ member companies participated in the ring analysis of the DNTB analysis method for SO_2 in beer.

6. Information disclosure activities

The 2022 BCOJ Annual Conference was held in a hybrid format on November 10th and 11th with President of ASBC, Kimberly Bacigalupo. The BCOJ Analysis Committee made an annual activity report of the Analysis Committee and made two oral presentations that were presented as posters at the Brewing Summit 2022.

The Program Committee has planned and managed the BCOJ Annual Meeting in order to "facilitate scientific and technological research through mutual communication among beer brewing industry specialists." and "work in collaboration with other foreign and domestic organizations having the same objectives"
