In 2024, we held the International Technical Committee meeting five times, the Analysis Committee meeting seven times, and the Program Committee meeting twelve times to realize the objectives of BCOJ activities. In May, we attended the EBC Congress as part of our overseas academic conference participation. Additionally, in August, we participated in the World Brewing Congress to update our collaborative declaration with the ASBC, "DECLARATION OF COOPERATION BETWEEN BCOJ & ASBC" and strengthened our relationship with the ASBC.

# 1. Science and Technology Exchange with the European Brewery Convention (EBC) and American Society of Brewing Chemists (ASBC)

# (1) Participation in EBC Congress

We participated on-site in the 39th EBC Congress and 6th edition of The Brewers Forum, interacted with EBC Board Members, and invited them to the BCOJ Annual Meeting.



(2) Participation in World Brewing Congress and update of "THE DECLARATION BETWEEN BCOJ & ASBC"

We participated on-site in the World Brewing Congress 2024 and updated "THE DECLARATION BETWEEN BCOJ & ASBC". A signing ceremony was held during the ASBC-BCOJ reception between BCOJ President Mr. Shioi and ASBC President Dr. Sylvie Van Zandycke. "THE DECLARATION BETWEEN BCOJ & ASBC" is to standardize experimental and analytical methods in brewing science and cooperate in the organization of events, and it has been updated every five years. With this renewal, the cooperative relationship between BCOJ and ASBC will continue until 2029.





#### (3) BCOJ Annual Meeting

The 33rd BCOJ Annual Meeting was held on November 7-8, 2024 at TKP Premium Kyobashi. Through presentations at the annual convention, which was attended by a total of 290 people from members of beer companies, related government agencies, and other companies, etc., we actively exchanged technical reports and opinions, leading to

the improvement of technical knowledge related to the development of attractive products, the achievement of deliciousness, and quality assurance.

From overseas, we welcomed ASBC President Ms. Lauren Zeidler and ASBC Asia Liaison Officer Dr. Xing Yin. Ms. Lauren Zeidler gave her keynote address on "Beverage Alcohol Consumer Trends: Insights from U.S. and Global Markets".

In addition, Dr. Kiyoshi Takoi from Sapporo Breweries Ltd. received the BCOJ Contribution Award this year.

Furthermore, Dr. Hikaru Kobayashi from The University of Tokyo gave an invited lecture.

# 2024 Annual Report of BCOJ Analysis Committee

#### 1. The BCOJ Collaborative Work

As the coordinating company, Suntory had completed preliminary investigations into the LC-MS analysis method for arabinoxylan in beer, and five BCOJ member companies then confirmed the peaks using standard materials. After that, four BCOJ member companies (excluding one company that was unable to use the equipment) and five instrument manufacturers began measuring representative beers from each company. As some companies did not obtain good results, the analysis conditions were re-examined. After that, the experimental plan and instructions were revised, and the nine companies began testing again (coordinating company: Suntory Spirits Ltd.).

#### 2. The revision of the BCOJ beer analysis method

The latest version of the beer analysis methods is the 2013 CD-ROM version, and it has not been updated since then. By the end of October this year, we had completed the third

proofreading of all 120 methods, and by the end of November we had completed the final proofreading and submitted them to the Brewing Society of Japan through the Brewers Association of Japan.

#### 3. BCOJ Technical Seminar

BCOJ Technical Seminar was held online from 15:30 to 17:00 on September 20, 2024, with about 80 participants.

Title: Future prospects for the risk of foodborne microorganisms, microbial testing / identification technology

Instructor: Dr. Takahisa Miyamoto, Professor, Faculty of Agriculture, Department of Bioscience and Biotechnology, Kyushu University

It was a meaningful study session, as we were introduced to the latest information and knowledge on hazards and accident examples other than food poisoning bacteria and microorganisms, as well as on microbial detection and identification technology in the food industry.

#### 4. International Activities

## (1) EBC Analysis Group conference

The EBC Analysis Group meetings were held on May 25th and 26th, 2024. Chairperson and vice chairperson of the BCOJ Analysis Committee and a general manager of BAJ participated in each meeting. And the BCOJ Analysis Committee Activities were reported in the final meeting.

# (2) ASBC Technical Committee meeting

On August 16th, 2024, the ASBC Analysis Committee meeting was held in Minneapolis before the WBC Congress 2024. The three members of the committee, the chair and vice-chair of the BCOJ Analysis Committee and a general manager of the BAJ participated, and Chairperson Muro reported on BCOJ activities.

#### (3) EBC Collaborative Work

In 2024, four BCOJ companies participated in the ring analysis, a detection method for beer-spoilage microorganisms using real-time PCR.

## 2. Objectives of the Program Committee

The Program Committee has planned and managed the BCOJ Annual Meeting to "facilitate scientific and technological research through mutual communication among beer brewing industry specialists." and "work in collaboration with other foreign and domestic organizations having the same objectives."

#### 3. Activities

The Program Committee held 12 meetings in 2024, including five regular and 7 extra sessions. Details are found in Chapter 4. The 2024 BCOJ Annual Meeting was held on November 7 and 8, 2024. This year, under the belief of "helping to raise the technical level of Japan's brewing industry," the BCOJ worked to improve the management methods at the new tournament venue, which was changed from last year, and improve conference content. Both participants and participating companies were the largest ever, with 287 registered attendees, representing 28 companies and organizations (excluding BCOJ member companies). In particular, craft breweries that were asked to have presentation last year continued to participate this year as general participants. We believe this is an indication that BCOJ has been able to provide a beneficial event not only for its member companies but also for the Japanese beer industry, including craft breweries.

The conference comprised of 24 presentations - 7 oral and 17 poster - from the EBC congress and World Brewing Congress. Lauren Zeidler, the ASBC Chair, delivered a keynote speech on "Beverage Alcohol Consumer Trends: Insights from U.S. and Global Markets". Research Advisor Dr. Hikaru Kobayashi from the Research Center for Advanced Science and Technology at the University of Tokyo was invited to give a lecture on "Improve the Environment and Enhance Added Value". In addition, five craft brewers gave flash talks and poster presentations with beer samples. Six analytical instrument maker companies exhibited their products. The conference was a success with high-quality and abundant content. The attendees actively engaged with one another, resulting in a fruitful event. Many individuals expressed their support for continuing the conference. We will continue to make improvements to make it an even better experience in the future.
